



## Shiner Downtown Trade Fair

Date of Show: Saturday March 20, 2010  
Time: 9am to 4pm  
Place: Downtown Shiner along 7<sup>th</sup> Street

### Rules:

- 1: Fee: \$25.00 per 12 x 12 space. Fees payable to Shiner Chamber of Commerce. Deadline is Wednesday March 10, 2010. \$35.00 is due thereafter and on the day of the show. Spaces will be assigned as payments are received.
2. There is no rain date. Participation is the choice of the vendor.
3. Check in time for space location and set up is 7:00 am to be ready to sell by 9:00 am opening time. Check-in station will be at the First National Bank at 103 W. 7<sup>th</sup> Street (adjacent to booth space). Vendors must check in for their assigned booth space. All vendors remain until 4pm closing time.
4. The Committee reserves the right to ask any vendor to leave the show or require removal of any items that are not acceptable. The show is designed as a family environment and behavior and items should be geared to this environment. You may be ask to remove projectile toys or other items that have potential to cause injury.
5. Food booths are limited. Commercial vendors must have a Texas Health Certificate.
6. Vendors are to furnish their own display installation. There is no covering provided and vendors will be responsible for their own set up and removal.
7. Vendors will be responsible for collection of local and state sales tax and for remittance to proper government authorities.
8. Parking will be available on the opposite side of the rail road tracks in close proximity to booth spaces and also along the street,
9. Spaces with electricity are limited and will be assigned as payments are received.
10. The Shiner Chamber of Commerce will not be held liable for any property damage, personal injury, or loss occurring in connection with the operation of the Shiner Downtown Trade Fair.
11. There will be a \$35.00 charge for all checks returned for insufficient funds.
12. NO REFUNDS will be made.
